

**TOWNSHIP OF CINNAMINSON  
ORDINANCE 2011- 15**

**AN ORDINANCE TO AMEND CHAPTERS 265 AND 381 OF THE GENERAL CODE OF THE TOWNSHIP OF CINNAMINSON ENTITLED “FEES” AND “PARKS” RESPECTIVELY TO ADJUST FEES FOR USE OF TOWNSHIP PARKS**

**WHEREAS**, the Recreation Advisory Committee reviewed current fee levels to ensure that significant users of parks and playgrounds bear the cost of maintenance associated with those uses; and

**WHEREAS**, this ordinance is enacted to implement those changes; and

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED**, by the Township Committee of the Township of Cinnaminson, County of Burlington, State of New Jersey that the below sections of the General Code of the Township of Cinnaminson be and are hereby amended and supplemented as follows:

**SECTION ONE.** Amendment to Chapter 265 entitled “Fees.”

Chapter 265 of the Township Code is supplemented to add a new section 265-27 entitled “Parks” to read as follows:

**265-27. Parks.**

Pursuant to Chapter 381, the Township establishes a Schedule of Fees attached hereto and incorporated herein which may be annually amended by Resolution. A copy of the current Schedule of Fees is available in the Township Clerk’s Office.

**SECTION TWO.** Amendment to Chapter 381 entitled “Parks”

Chapter 381 of the Township Code is supplemented and amended to renumber section 381-6 to 381-7 and to create a new Section 381-6 to read as follows:

**381-6. Facility Use Policy; Fees**

- A. The Township hereby creates a Facility Use Policy requiring all groups, organizations and leagues to pay a fee for use of municipal facilities.
- B. The Cinnaminson Township School District and Cinnaminson Senior Citizen Organizations are exempt from all fees. Private schools are not exempt from fees and shall pay based upon Schedule A of the Facility Use Policy and Schedule of Fees.
- C. The Township Recreation Advisory Committee shall annually review the Facility Use Policy and Schedule of Fees and may recommend changes to the Township Committee. The Township Committee may amend the Schedule of Fees by Resolution annually. The existing Schedule of Fees shall remain in effect until amended.

**SECTION THREE.** Repealer, Severability and Effective Date.

A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.

B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.

C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
