CINNAMINSON TOWNSHIP COMMITTEE REGULAR SESSION MINUTES April 15, 2019

Mayor McGill announced that the Regular Meeting of the Township Committee is being held at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. This meeting is being held in accordance with the "Open Public Meetings Act," P.L. 1975 c.231, having been duly noticed to the Burlington County Times and the Courier Post on January 11, 2019.

In attendance: Mr. Conda, Mrs. Kravil, Mr. Segrest, Mayor McGill. Also present: Eric Schubiger, Administrator; Julia Edmondson, CFO; Stuart Platt, Solicitor;

Chief Calabrese presents Police Department Officers with awards.

Presentation by David Wyche from the Burlington County Department of Economic Development regarding their Small Business Loan Program.

Liaison Reports:

Administration and Health & Senior Services - Committee Member Conda

Cinnaminson has been awarded \$252,000 by the Department of Transportation 2019 Municipal Aid Program. This will be used for Phase II of the reconstruction of Union Landing Road. Secondly, CPR and AED training was provided by the Garden State Municipal Joint Insurance Fund. All 36 municipalities who are part of the JIF participated in a wellness challenge. 45 Cinnaminson employees took part in the challenge. Cinnaminson Township won as we had the highest percentage of employees participate. Also new work flow software is being implemented within the Township. The software will assist the staff by allowing for better efficiency. As it is rolled out it will also allow residents to submit concerns and requests through the software as well as provide a better means to reserve facilities and field use within the Township. Training on this began with the staff last week. Lastly, Fox 29 contacted the Township to ask us to participate in the Town Takeover event that they have scheduled at The Breakfast Nook on April 29th from 4 to 10:00 am. It's an opportunity for Cinnaminson to come out and show your Cinnaminson pride. That concludes my report.

Public Works – Committee Member Segrest

I'd first like to give an update on the East Riverton Drainage Study. Cinnaminson Township with the help of Pennoni Engineering has been conducting a study of drainage concerns in portions of the East Riverton section of the Township. Pennoni has finalized their proposal for the scope of the work and an informational session has been scheduled. Properties in the study area were mailed letters notifying them of the date and time of the information session.

Department of Public Works activity since our last meeting – Brush and leaf pickup continued. April was leaves only. The processing of brush, leaves mulch and street sweeping, removal of 13 dead trees, grinding of trees stumps, filling potholes, maintenance of the parks in preparation for

baseball and softball opening days. They did a great job in preparing those fields. They have been doing spring cleaning around town hall, police station and library including installation of landscaping, shrubbery at Wood Park, concession stand and around the digital sign at town hall. They continue cleanup of Poets Walk pocket park including, cleaning of town hall, library and police department, maintenance of public works and police department vehicles and equipment. Daily recycling hours are 7:30 am to 12:00 pm collecting electronics, TV's, microwaves, tires, paint, leaves and brush. That concludes my report.

Finance and Veterans Affairs - Committee Member Kravil

For finance the resolution to introduce the 2019 budget is on tonight's agenda. As chair of the finance subcommittee myself, Deputy Mayor Horner, Administrator Schubiger and CFO Edmondson have spent a lot of time examining and fine tuning the budget. While collectively we take pride in this budget I want to take a moment to thank our CFO who worked extremely hard on this budget all year long. Thank you Julie. You will notice that the budget for 2019 is calling for no municipal increase. The municipal tax rate will be stable once again this year. I am so proud of the work that the CFO, with the administrator and this team were able to accomplish with keeping this stable budget, all without decreasing any municipal services. As per tradition and formality at our May 20th public meeting a presentation of the budget will take place to provide further details and answer any questions. We are also introducing a capital ordinance for 2019 which will include proposed capital improvements. The ordinance will include the Wayne Avenue Bridge. This is a long awaited project that has been in the works for years. We are pleased that the needed improvements will be addressed.

For veteran's affairs we are in discussions to finalize a Memorial Day ceremony. The administrator has met with Chief Calabrese, Chief Kramer to coordinate a ceremony that will take place here at town hall. The time and specific program information will be available in the next couple of weeks. This concludes my report.

Parks & Recreation and Economic Development – Administrator Schubiger

On the Economic Development we are making great progress with the Lidl project. There is constructive DOT approval on that project. We are moving in the right direction. The Burger King project is moving along. Also Starbucks has now opened. We are hoping for a ribbon cutting ceremony to take place very soon. In addition, the Chase Bank will be opening on May 10^{th} as of now. There will be a Grand Opening. I will follow up with committee on the date and time. For the Siena project is moving along. The MEND project has seen great progress. Finally, I know everyone can understand that I can't give too many details at this point but there is much interest in the Azalea Farm Property.

For Parks and Recreation both baseball and softball have had their opening days. All of our spring programs are in full spring. One of the things we are doing with our Gov Pilot software is trying to improve facility building use for in house staff and general public to make that process easier. We are excited about getting that off the ground.

Public Safety – Mayor McGill

March activity report since the last meeting total incidents responded 1145, total arrests 82, total quick calls 1210, total motor 362, motor vehicle summonses 380, total DWI 5. On April 5, 2019 Cinnaminson Police were notified by MADD that Police Officer Garrett McLaverty has been nominated and will be recognized for distinguished service to our community for DWI/DUI enforcement in 2018. On June 13, 2019 Police Officer McLaverty will be receiving the Recognition of Excellence Award at Rutgers University located in New Brunswick, New Jersey.

Lastly, Thursday, April 11th Cinnaminson Police Department executed a search warrant on the 1500 block of Wynwood Drive. Police said they shut down a narcotics operation after a fourmonth investigation. Detectives seized heroin, methamphetamines, fentanyl pills, LSD, marijuana and packaging materials intended for distribution as well as 100 used hypodermic syringe needles scattered throughout the residence. Eight adults living in squalor were arrested as a result of the investigation. They were all charged with a list of offenses including possession, distribution of CDS in a school zone, possession of an imitation firearm and drug paraphernalia , possession and distribution. The Cinnaminson Police Department worked in conjunction with the New Jersey State Police and Riverton Borough and thanks them for their assistance. I'd also like to thank the men and women of the Cinnaminson Police Department. As Chief Calabrese said these awards; it has been eight or nine years since they were brought back to the public and I'm glad to see them back. Chief Calabrese you have a fantastic department. Thank you.

ORDINANCE OF THE TOWNSHIP OF CINNAMINSON, COUNTY OF BURLINGTON, AND STATE OF NEW JERSEY, AMENDING CHAPTER 330 ENTITLED, "LAND USE PROCEDURES" AND CHAPTER 10, ENTITLED "ADMINISTRATION" OF THE CODE OF THE TOWNSHIP OF CINNAMINSON

WHEREAS, Chapter 330 of the Code of the Township of Cinnaminson, entitled "Land Use Procedures," provides rules, regulations and standards to guide land use applications in the Township of Cinnaminson so as to promote the public health, safety, convenience and general welfare of the municipality; and

WHEREAS, the Zoning Officer and the Site Plan Advisory Review Committee are tasked to determine whether a full site plan and submission to the Planning Board is required; and

WHEREAS, to better promote the health, safety, convenience and general welfare of the residents of Cinnaminson Township, the Mayor and Township Committee have determined that the membership of the Site Plan Advisory Review Committee should be composed of the same membership as the Economic Development Committee; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:48-2, the Governing Body is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Township by law.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Mayor and Township Committee of the Township of Cinnaminson, County of Burlington and State of New Jersey as follows: **SECTION 1:** Article III, entitled "Departments Generally," of Chapter 10, entitled, "Administration," is hereby amended, revised and/or supplemented to read as follows:

Article III. Departments Generally

§ 10-9 Department liaisons.

Pursuant to the provisions of N.J.S.A. 40A:63-7, members of the Township Committee shall serve as department liaisons to various departments, offices and positions, and said designation shall be by the Township Committee. Each member of the Committee shall be department liaison to at least one Township department, and, if necessary, position or office. Duties of a department liaison shall be to:

AN ORDINANCE TO AMEND CHAPTER 265 RELATING TO FEES, AND SPECIFICALLY, § 265-2 RELATING TO FEES FOR OUTSIDE EMPLOYMENT OF POLICE OFFICERS

WHEREAS, the police department has requested an amendment to the per hour fee charged to private vendors who contract off duty police officers for traffic and crowd control so the same properly reflects the cost of service without a burden on the taxpayer; and

WHEREAS, the Township has determined that further adjustments are appropriate.

The remainder of the Chapter shall remain as adopted by Ordinance 2014-8

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, that Section 265-2(A) of the General Code of the Township of Cinnaminson relating to police outside employment contracts is amended to change the rate from "\$65 per hour" to "\$85 per hour." that Section 265-2(B) of the General Code relating to administrative fee is amended to change the rate from "\$50 per day" to "\$15 per hour or a minimum of \$50 per day" that Section 265-2(C) of the General Code relating to Municipal vehicle used by private employer: is amended to change the rate from "\$12.50 per hour" to \$18.50 per hour or from \$100 per day for an eight-hour day per vehicle to \$150 per day for an eight-hour day per vehicle.

REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. <u>Repealer</u>. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability.</u> In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. <u>Effective Date.</u> This Ordinance shall take effect upon proper passage in accordance with the law.
