The Regular Meeting of the Township Committee was called to order by Mayor Minniti at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. Mayor Minniti opens the meeting with the Pledge of Allegiance.

Presentation from PSE&G re: Vegetation Management – Rich Arnold Presentation is in accordance with 2010 agreement regarding vegetation management along the transmission border. All property owners affected have been noticed. Mayor Minniti explains the process for PSE&G to do vegetation clearance. Mayor Minniti offers for them to meet with the residents in the conference room. PSE&G adjourns to conference room with residents to answer any questions.

Health and Senior Services and Veterans Affairs – Mr. Evans – Nothing to report.

Parks and Recreation – Mr. Brauckmann

Hope everyone's summer is going well. I just wanted to provide everybody with a few updates as to what has been going on in the Parks & Recreation World.

Summer Concerts have been concluded with our final concert that was held last Wednesday night. This year we held 5 concerts. Next year I would like to make the recommendation that we change our scheduling to only do 3 major concerts (1 in June, 1 in July, and 1 in August) on Saturday nights. I would like to book bigger bands and actually make these events larger. I would maintain the Kiddie Concert but I would like to recommend that this be incorporated with one of the police movie nights that target a younger audience. I am fully open to working with our PD to try to make our children and other events better. I ran this idea by the Parks & Recreation Committee and they are favorable to this idea so this will be the direction we will be taking our summer concerts next year. I am ready working in of concert events for next year.

Summer Tennis lessons also concluded last month and was another great success. This year we accommodated 77 - 5 to 9 year olds, 59 - 10 to 15 year olds, and 3 over 15 year olds all of which are Cinnaminson residents. Great job to all of our tennis instructors and especially Ike Johnson who has been with Cinnaminson since 1998, making this his 19^{th} year.

This year's Cinnaminson Day will be held on Sunday, October 15th, from noon to 3pm. The rain date will be the following Sunday, October 22nd. The business and group registration letter and information packet will be coming out this week so stay tuned.

This year's Trunk or Treat will be handled by CHS Project Graduation and will be held at CHS on Saturday, October 21st. This event is posted on social media and information will be distributed through our schools soon.

A charity run was requested and was denied by township committee last month because our new ordinance does not cover these types of events and there were some concerns raised regarding events like this. Ben Young recommended that I work with him and our Administrator and attorney to try to include language in our recently passed ordinance to include these types of events. Although we haven't met yet, I am happy to be included in this group and appreciate Committeeman Young for nominating me to serve in this sub-committee once again. Ben Young only has 3 months remaining on committee so hopefully we can get this done this year. If not, a new committee will review this as well as any other issues that may come up with our new ordinance. Stay tuned.
