December 2, 2019

Meeting Minutes

Mayor McGill announced that the Regular Meeting of the Township Committee is being held at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. This meeting is being held in accordance with the "Open Public Meetings Act," P.L. 1975 c.231, having been duly noticed to the Burlington County Times and the Courier Post on January 11, 2019.

In attendance: Mr. Conda, Mrs. Kravil, Mr. Segrest, Mr. Horner, Mayor McGill. Also present: Administrator Eric Schubiger, CFO Julia Edmondson, Municipal Clerk Lisa Passione; Michael Minton, Director of Economic Development; Alen Arnautovic, Solicitor.

Mayor McGill opened the meeting with the Pledge of Allegiance.

DISCUSSION ITEMS

Route 130 Pedestrian Road Safety Audit – Mr. Schubiger reported that we are in receipt of the audit from the State and it is available for review in the Clerk's office. This is for improvements in the crosswalks from Taylors Lane to the Delran border.

Ben Young, 116 Woodview Lane – Expressed concern regarding the resolution acknowledging EMS services being provided by the Fire District. He has questions regarding hard billing vs. soft billing.

Committee Member Horner asks Mr. Young to expand on his concerns. He requested that Chief Kramer respond to questions from the public.

Michael Goins, 100 Purnell Ave. – Stated that he agreed with Mr. Young. He would have liked more open discussion. He is concerned with soft billing vs. hard billing.

Committee Member Horner responded that the Township's legal counsel has been working with the DCA's legal counsel to create a document that would satisfy the DCA's requirements as well as the Township's.

Chief William Kramer, Cinnaminson Fire District responded to questions from the public. This is a collaborative effort. He cannot say if billing will always cover the cost of the services. The billing is not changing. The agreement is an operational agreement. The policy and procedures are exactly the same.

Mr. Schubiger responded regarding the timeline and transparency.

Seeing no one else come forward Mayor McGill closed public comment on the consent agenda.

PUBLIC COMMENT

Mayor McGill opened the Public Comment portion of the meeting.

Chief William Kramer, Cinnaminson Fire District – Asked if the Pedestrian Road Safety Audit looked at traffic signals, specifically Route 130 and Taylors Lane. Committee advised that it did not. He believes this intersection is an issue; that there was supposed to be a preemption device installed. He requested that the Township have their engineer review this intersection. Mr. Schubiger will contact Pennoni.

Ben Young, 116 Woodview Lane – He also believes that a left turn signal is needed at Route 130 and Taylors Lane. Mayor McGill requested that Chief Calabrese compile data on accidents in this intersection. He also inquired about the cannabis subcommittee.

Richard Dietrich, 9 Emerson Drive – Commented on the work that the Fire District does. He sees what the fire department staff does; it is remarkable and should be taken into consideration.

Seeing no one else come forward, Mayor McGill asks for a motion to close the public comment portion of the meeting
