CINNAMINSON TOWNSHIP COMMITTEE December 5, 2016

The Work Session Meeting of the Township Committee is being held at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. This meeting is being held in accordance with the "Open Public Meetings Act," P.L. 1975 c.231, having been advertised in the Burlington County Times on January 5, 2016 and sent to the Courier Post on March 22, 2016.

Committee Members Present: Mr. Brauckmann, Mrs. Fitzpatrick (speakerphone), Mr. Minniti, Mr. Young, and Mayor McCarthy. Also Present: Attorney George Morris, Director King, Administrator, Committeeman Elect Bud Evans, Michael Minton, Director of Economic Development

Mayor McCarthy opens the meeting with the Pledge of Allegiance

Mayor McCarthy requests a moment of silence for Officer Frank Rooney, retired who passed away today.

Kathryn Windsor from Tilson Technology for Verizon Wireless gives a presentation re: Verizon doing work in Township right-of-way for upgrades to telephone poles; requests Committee's permission to work on telephone poles in right of way. Will secure all approvals from Construction Dept. prior to beginning work.

Motion to Approve Resolution 2016-135 Granting permission to Verizon Wireless to access poles in Township public right-of-way. Motion to approve is made by Mr. Young, seconded by Mayor McCarthy. All aye. Motion approved.

William Juliano, from Cinnaminson Commercial LLC, gives a presentation on the proposed Wawa at Route 130 and Branch Pike. Committee comments that they would like both Wawa's to be comparable in style. Motion to approve the redevelopment application as to its use, architectural and planning consistencies as well as authorizing Economic Development Committee to move forward working with Cinnaminson Commercial LLC on this project made by Mr. Young, seconded by Mr. Minniti. Ayes – Mr. Brauckmann, Mr. Minniti, Mr. Young, Mayor McCarthy. Mrs. Fitzpatrick abstains.

Old Business

Tree Removal – Scott Salvano from Public Works is present. Director King points out that we need to address the existing list of residents who were told that we would remove trees and what the policy will be going forward. Discussion ensues. No resolution is reached. Committee directs Scott to work on the existing list; he can add any dead or diseased trees to the list. Committee to reach out to surrounding municipalities to see how they handle this situation.

New Business

Solicitor's permits – Mayor McCarthy received a phone call from a resident questioning why the Township allows solicitors. He suggested that she use a "No Solicitors" sign. The

process is reviewed with Director King. Mr. Morris states that banning solicitation would be a constitutional issue. Director King suggests that solicitors will be advised that if they solicit at a home where "No Solicitations" is posted they will be cited.

Police Chaplain – Director King requests that the Police Department have an official chaplain. Reverend Doll is interested in accepting this position. Motion to approve Director moving forward made by Mr. Young, seconded by Mr. Brauckmann. All aye. To be done yearly by resolution at the reorganization.

Body cameras for Police – Director King feels that it is time to look at body worn cameras for our officers. Our current vendor for cameras now has body worn cameras. We are hoping to get demos from them in the next two to three weeks. There is also a second round of funding through the Attorney General's office. Director King has started the application process. We will work with the budget committee next year to find the money and will hopefully receive \$15,000 to \$20,000 from the Attorney General's office to offset it. Committee approves for Director King to move forward with applying for grant money.
