REGULAR SESSION MINUTES

March 18, 2019

Mayor McGill announced that the Regular Meeting of the Township Committee is being held at 7:35 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. This meeting is being held in accordance with the "Open Public Meetings Act," P.L. 1975 c.231, having been duly noticed to the Burlington County Times and the Courier Post on January 11, 2019.

In attendance: Mr. Conda, Mrs. Kravil, Mr. Segrest, Mayor McGill. Also present: Eric Schubiger, Administrator; Julia Edmondson, CFO; Alen Arnautovic, Solicitor;

Mayor McGill invites Cinnaminson Boy Scout Troop 70 to present the Flags and to open the meeting with the Pledge of Allegiance. The Boy Scouts also recite the Scout's Oath.

Mayor McGill presents Proclamation to new Eagle Scout Benjamin Ross.

Liaison Reports:

Administration and Health & Senior Services - Committee Member Conda

Our Nixle alert system is being expanded to include community information. This new Nixle engaged platform has been launched and it is already being utilized to inform residents of pertinent Township activities. To register for the new platform residents should text 08077 to 888777.

Administrator Schubiger and CFO Edmondson have continued to meet with brokers regarding the providing of gas and electric to Township facilities. The Township is examining alternatives with the goal of realizing a significant energy cost savings. Also Administrator Schubiger and CFO Edmondson, Chief Calabrese and Lt. Johnson met with the Township's IT provider to discuss phone and email systems and services. There are some significant cost savings that can be realized by making changes to both. The specifics to make these changes are being worked out.

Lastly the March newsletter has been published on the Township website and Facebook page. Cinnaminson Township news is generally published on a monthly basis to provide residents with pertinent information and reminders related to Cinnaminson Township and the surrounding area. The Township uses this as another important means of keeping our residents informed about our community. That concludes my report.

Public Works – Committee Member Segrest

Department of Public Works activity since our last meeting – Brush pickup and street sweeping began March 1st. Filling potholes throughout the Township is still a challenge. We salted roads on four separate occasions. Cleanup of overgrown basins and drainage swales behind city hall complex. Preparation for spring sports along with liming of the fields along with regular maintenance and cleaning of the parks. Cleanup of Poets Walk Pocket Park including removal of numerous dead trees. Upgrades to the Police Station, gym, locker room and new TV's in this courtroom and the conference room in the back. Recycling hours at Public Works are 7:30 am to noon, daily for collection of electronics, TV's, microwaves, tires, unused paint, leaves and brush. This concludes my report.

Finance and Veterans Affairs - Committee Member Kravil

The finance committee is working hard on finalizing our municipal budget. We plan to introduce the 2019 budget in April.

In regards to Veterans Affairs, the Township has received a lot of positive feedback on the Combat Wounded Parking sign that we have placed in the town hall parking lot. At this time, we are in the process of looking at additional places to locate the Combat Wounded spaces.

There is a subcommittee in place to establish a permanent 911 Memorial. This subcommittee will meet March 23rd and consists of myself, Committee member Segrest, Fire Chief Kramer, Police Chief Calabrese and Emergency Management Coordinator Danny Norman. This concludes my report.

Parks & Recreation and Economic Development - None

Public Safety – Mayor McGill

Since February's meeting total incidents responded to was 965, total arrests were 64, quit calls were 966, total motor vehicle stops were 255, total summonses were 227 and total DWI's were 4.
