Old Business

Redevelopment agreement for Brixmor/Shoppes at Cinnaminson Redevelopment for discussion. MR. MINTON speaks. Brixmor would like to add 3 new sites, change some lighting and increase signage. Brixmor requests Committee to approve the second amendment to the redevelopment agreement subject to the final approval of the solicitor and Township Administrator. We need to have the amendment in place so they can be heard by the Planning Board on April 12th.

John Gillespie: Resolution is needed authorizing amendment. Committee agrees resolution to be added to Consent Agenda for March 21, 2016.

Trees

BEN YOUNG: Issue continues with residents wanting trees to go away. We have no tree ordinance at this time. We need a uniform policy. Discussion to be continued on April work session meeting.
