October 16, 2017

The Regular Meeting of the Township Committee was called to order by Mayor Minniti at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. Liaison Reports

Health and Senior Services and Veterans Affairs - Mr. Evans

Good evening everyone and welcome. First I've been working diligently to fill the home at 553 Inman St. with Ashley from Habitat for Humanity. It appears as though we finally have that filled. It's good to see a military family in need be provided with a helping hand. We'll begin accepting applications for two veteran's builds which appear to be moving quickly in Palmyra.

We have a date for the Senior dinner. Mr. King, Office Mike and I will be working on that over the next couple of months. We are looking to have it outside the community center for maximum participation from the seniors. I'll have more on that as time progresses.

I'll be working with Mr. Valkenberg and a Memorial Day committee for next year. It's my expectation that weather permitting we'll be able to hold this at Memorial Park. Mr. Brauckmann has been kind enough to help us out with that. He is participating as a liaison for Parks and Rec.

Saturday, Nov 18[,] 2017 at 12:00 is Take a Veteran to Lunch Day at The Burlington Masonic Lodge #32. It's off of 47A. I'll have more information on that as time progresses.

Parks and Recreation - Mr. Brauckmann

For October's Parks and Recreation report I have the following to offer. Our Parks and Recreation Advisory Committee met in the beginning of the month and we will be scheduling a meeting with all of our sports boards as well as regular users of our parks. We plan to advise them of the requirements of the newly adopted parks ordinance and to make sure they understand its requirements for end of the year reporting to our Administrator. We will also be requesting their feedback on the parks ordinance for changes and modifications next year if necessary. Also, due to the advisory board diminished role over the past several years, there were discussions about requesting to disband the group entirely next year or to minimizing our meetings to only several key times of the year. With hopes of a better future starting January 1st, the group decided to maintain the course but to limit our meetings to several key times of the year. These times will be: February when permit request are turned in, reviewed, and recommended to approval as well as the permit requirements which can be properly explained if necessary, before summer for mid-year issues that may arise, and in November to again conduct an end of the year brief and to prepare our park permit users of their end of the year reporting requirements.

There have been several exciting improvements being made to our parks and I want to thank our public works department for all of their continued hard work to make improvements to our parks and for all the continued upkeep and maintenance. I receive a lot of compliments while in our parks which I am in quite a bit and I too notice so I just want to relay to our employees everyone's appreciation, myself included.

Last month at the end of the meeting there was a comment made from another committeeman attempting to place blame on me for letting the 9/11 memorial efforts go into Limbo. While this committeeman was correct about our last ceremony being in 2013, not 2012, he was incorrect in stating that I was on the committee that was formed as a result of the last memorial ceremony we had in 2013. In fact, after word of this committeeman's comments got out to our public, I was contacted by several of the members who were in fact on the 9/11 memorial committee and was also forwarded several email chains which ended in November of 2015, not 2013. Again, let the record reflect that I was not included in this email chain because I was not on this committee. None the less, I am not the type of person to cast blame on anyone for this delay but I will say that since my comments on 9/11 of this year, there has been renewed discussion and interest in getting something done soon. This time I plan on being included in the plans with this group, that talks have restarted, and we hope to have something done sometime next year.

Finally, this past Sunday we had our Cinnaminson Day. This year's event was in my estimation, one of our largest attended events. Special thanks to all of our participants, food vendors, and township services including our Public Works Department, Fire Department, Police, EMS Services and also to CHS Project Graduation for hosting the car show. I also wanted to send a special thank you to the Armed Forces Mobile Heritage Museum for accepting our invite and participating. I want to give special praise and recognition to Pat Rucci for all of her coordination and Christine Turner for assisting with check in and set up this morning. These two people exemplify great citizens who always go above and beyond for their community. Finally, to our public works department for setting everything up and breaking everything down. This event is a true TEAM effort and couldn't be possible without everyone that was involved to make it the success it is.

From our businesses, to our sports groups, community and school organizations, to our township services, Cinnaminson Day is a day that highlights everything that makes our town such a wonderful place. If anyone ever wanted to see what Cinnaminson is really about, this was certainly the place. Everyone there was smiling and very appreciative of our largest community event. For me, it exemplifies what makes our community such a wonderful place. With all the

negative things going on in the news recently, this event shows the true character of our community. I had so many people coming up to me and telling me how much they appreciate this event and are excited for Cinnaminson's future. This event always makes me smile but this year was extra special as people really went out of their way to let me know how much they appreciate everything and how sincerely supportive they are. Cinnaminson Day is all about our people and our community and this event showed yet again, that we are <u>#CinnaminsonStrong</u> and #CinnaminsonProud

Public Works - Mr. Young

Good evening Mr. Mayor and to all.

First of all, I am pleased to report that our fall clean-up day at Public Works was very successful. We had more than 210 residents visit us with materials for disposal and recycling. Some even came more than once. We collected more than two (2) truckloads of electronics to be recycled.

We are currently making our final pass of the year through town for the pickup of brush. If we have been through your section of town this month, we have made our last trip. We want to remind all of our residents that we will not be picking up brush again until March of 2018, weather permitting.

We will begin our fall leaf pick up schedule the first full week of November, which will be starting Monday, November 6th and will continue through the end of December. State regulations for leaf handling are very restrictive so please do not put your leaves in the street prior to the weekend of your area's scheduled pickup. Please do not mix any brush with leaves or we will not be able to pick up and process.

We have completed our major paving program for the year. Our last project was the complete reconstruction of approximately 2,000LF of Union Landing Road. The work could not have been completed without the full cooperation of the local residents of both the homes and the business entities that were affected during the construction period. Good weather also was a major factor in our success. I want to take this opportunity to mention the efforts of the affected businesses with the major parties of both Seabox and Hoeganaes being a very significant key to creating and implementing a plan that enabled us to take the business traffic off the road for nearly a week. Through the joint cooperation of Hoeganaes and Seabox, we were able to create an alternate access for the Union Landing business operators, allowing them to enter and exit from Taylors Lane through the Hoeganaes property. Seabox constructed a connection ramp between themselves and Hoeganaes and an opening was created through the common fence allowing for all parties to exit out onto Taylors Lane for the construction period. We worked with Jill Morrison of Airgas to get them to take early deliveries and then delay any new incoming materials for the next 4 days. Airgas could not get a driveway connection w/Seabox, but were able to bring their employees through Hoeganaes and Seabox allowed them to park in the lower end of their property where they were able to utilize the personnel gate that connects the properties for employee access. Jay Myles of the Myles Transportation group created an access between his facility and Seabox so they could utilize the alternate route to Taylors Lane. This access was also set up and available to be utilized by Airgas if an emergency response should occur at their facility. The success of the project was the result of all of these collective

efforts and we extend our deepest thanks and appreciation for the team effort and cooperation of all the business owners and management involved.

In conclusion, my thanks to the entire Public Works staff for their efforts in helping the town have another successful and enjoyable Cinnaminson Day yesterday. This is a group effort and once again they have done a great job.
