First of all I wish to remind everyone that our fall cleanup day is scheduled for this Saturday, Oct 1st. We will be there from 8 am to 2 pm. It is available to Cinnaminson residents only.

We completed our annual street paving program last week. We have one remaining street, Ivystone Lane which has been deferred to next year due to a sink hole. We are getting prices to repair. Indications are that it's a crushed storm drain about 10' below grade. We do still have to change out grates for the storm drain inlets. There will be no more interruptions for paving.

We've rewarded the reconstruction work for the Wood Park tennis courts. It is currently scheduled to begin at the end of the high school tennis season which is late October. Funding for this capital project is a joint venture between the Cinnaminson School District along with our capital and our open space grant from the County. These courts are our high school tennis team's home courts.

We continue to work on a number of projects that are in various stages of progress and development of project scopes for bid purposes. We will be awarding the Memorial Park parking lot and concession stand in the next two weeks.
