# March 2, 2020 Meeting Minutes

### **PUBLIC COMMENT**

Mayor Horner opened the Public Comment portion of the meeting.

Michael Goins, 100 Purnell Ave. – Asked if the Township has made a determination as to whether residents can use their own second can. Mr. Schubiger responded that they cannot. He also questioned the complaint log kept by Republic Services. Discussion ensued regarding the status of the current service and what can be done to improve it.

Thomas Chichester, 702 Wood Lane – Advised committee of instances where trash was dropped by Republic and not picked up. Mr. Schubiger stated that the side load trucks should be in use in 2 to 3 weeks which will improve this situation.

Ben Young, 116 Woodview Lane – Also commented on trash pickup and residents putting bulk pickup out too early. He then asked what the status of the Wayne Drive bridge project is. Mr. Schubiger advised that Alaimo is on track for us to award in April. Mr. Young also commented on the asphalt on Willow Drive and what the status of the drainage program is. Mr. Segrest stated that the Sewerage Authority has started cleaning. They are going to clean, rebuild the headwall and put in duck bills. DPW is going to clean out that whole area. Mr. Schubiger clarified that they will follow DEP regulations. He then asked about the marijuana subcommittee. Mrs. Kravil said that the subcommittee is waiting for more news from the State. Mr. Young then asked about the industrial redevelopment standards. Mr. Minton responded that the Economic Development is meeting with SeaBox and the planner on March 11<sup>th</sup> and they will then have a presentation in April. Lastly Mr. Young comments on Whitesell building that are for sale.

Thomas Chichester, 702 Wood Lane – asked if Mr. Schubiger had heard back from Mosquito Control about what specifically they spray. Mr. Schubiger had not but will reach out to them again and get back to Mr. Chichester.

Seeing no one else come forward, Mayor Horner closed the public comment portion of the meeting
