## RESOLUTION 2020 – 113

### **RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR ABI FORCE FIELD GROOMER**

**WHEREAS**, the Township of Cinnaminson Department of Public Works has a need for a field groomer as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5 or 20.5 and,

**WHEREAS**, the purchasing agent has determined and certified in writing that the value of the contract does not exceed \$44,000; and,

**WHEREAS**, the anticipated term of this contract is through project completion; and,

**WHEREAS**, Lawn and Golf Supply Company Inc. has submitted a proposal dated September 21, 2020 indicating they will provide the ABI Force Field Groomer for \$28,373 (Twenty-eight thousand three hundred seventy-three dollars); and

**WHEREAS**, Lawn and Golf Supply Company Inc. has completed and submitted a Business Entity Disclosure Certification which certifies that Lawn and Golf Supply Company Inc. has not made any reportable contributions to a political or candidate committee in the Township of Cinnaminson in the previous one year, and that the contract will prohibit Lawn and Golf Supply Company Inc. from making any reportable contributions through the term of the contract, and

**NOW THEREFORE, BE IT RESOLVED** that the Township of Cinnaminson authorizes a contract with Lawn and Golf Supply Company Inc. as described herein; and,

**BE IT FURTHER RESOLVED** that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.

**AUTHORIZING CINNAMINSON TOWNSHIP TO FILE APPLICATIONS  
WITH THE GOVERNOR’S COUNCIL ON ALCOHOLISM AND DRUG  
ABUSE FOR FISCAL YEAR 2020**

**WHEREAS**, Cinnaminson Township Municipal Alliance has been organized to provide programs to encourage development without drugs by virtue of care, education and vigilance; and
