Meeting Minutes

Mayor Segrest announced that the Regular Meeting of the Township Committee is being held electronically at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. This meeting is being held in accordance with the “Open Public Meetings Act,” P.L. 1975 c.231, having been duly noticed to the Burlington County Times and the Courier Post on January 8, 2021.

The first item I’d like to talk about this evening is to recap a meeting of the Drainage Subcommittee that I attended last week to go over the work that is being done in East Riverton and the plans for continued improvement. The meeting included myself, the Mayor, some Township staff and some members of the public. The entire stormwater system in East Riverton has been jet cleaned to provide better water flow and the new duckbill valves were installed. Currently the rebuilding of North Pompess has been completed with only a few items left. The work there included total reconstruction of the street. These improvements have significantly reduced the standing water in the street. We have plans to do the same work on North Randolph in the fall. We also talked about a workable maintenance schedule for these valves and the runoff areas. On the Kern, Zeisner, Inman side of East Riverton the engineers outlined work that the DEP is starting which will include an extensive cleanup of the area between Zeisner and the river and the surrounding drainage areas which should lend to a significant reduction of standing water on those three streets and
