Liaison Reports

Administration and Health and Senior Services – Mr. Conda

I'd like to welcome everyone back into the building. I am glad to be back. I have a few items. I have a couple things that I want to address that are on tonight's agenda. We have a couple of grant applications that we are going to introduce tonight. One is for the reconstruction of Kern Street; one is for the reconstruction of Zeisner Street. This is part of our ongoing effort to alleviate the flooding in East Riverton. Last year we used money that we were granted to resurface North Pompess. This year we are going to use grant money to do the same for Randolph. If we get the grant for Kern Street and Zeisner Street, that will be two more. The DEP is going to resurface Inman Street. That accounts for every residential street between the railroad tracks and the river. That is all I have to report

Finance and Economic Development – Mr. Horner – Nothing to report

Public Safety – Mr. McGill

For the May activity report for the Police Department – Total incidents – 1980, total arrests – 16, total property checks – 515, total motor vehicle stops – 222, total motor vehicle summons – 161, total DWI arrests – 4.

On June 12th Cinnaminson Township Police held a successful bike safety event at Memorial Park. During this event every child was given the opportunity to obtain a free bicycle helmet, was provided bike safety tips and enjoyed a BMX bike show. We would like to thank everyone who attended. Parks & Recreation and Veterans Affairs – Mrs. Kravil

We have a lot of great things happening. This Thursday, June 24th at 5:30 pm in Wood Park we will be hosting Cinnaminson's Got Talent. This is a great opportunity for everyone to come out and see our residents showcase and exhibit their fine talents. We also have a full summer concert series starting Thursday, July 8th at Wood Park. The first featured band will be Jimmy and the Parrots. With the expanded openings within the Township and the Township buildings, the community center is now open and the senior activities that were regularly scheduled can resume.

Lastly, Township Committee has applied for a grant to help refurbish Riverton Park. The Township engineer presented Township committee with a brief concept of potential plans earlier this evening. We will keep the residents informed of the process as we expand on this exciting proposal and as soon as more information is available. Thank you. That concludes my report.

Public Works – Mayor Segrest

I want to mention the road improvement program for 2021. We are going to be repaying the full length of Hope Lane and the full length of Stephen Drive. Part of the reason those were chosen is that there is no utility work being done. In town there has been a lot of utility work. It would not be prudent to pave an area that was then going to be dug up. We are also going to pave the hill lot at Memorial Park and the concession lot at Memorial Park as well as a small part of the DPW lot.

Recycling as of right now per the County is tentatively scheduled to be picked up next week. We know that that can change. To combat that the Township has made available at Public Works 4 - 8 yard dumpsters in a self-service area which is available twenty-four hours a day. There is also a 30-yard container available on Saturdays from 8 am to 12 pm. We will continue doing that. The 4 - 8 yard containers will remain for recycling. Residents can also drop off brush and other items.

As far as drainage, as Mr. Conda mentioned, regarding Kern and Zeisner streets, DPW is continuing the household sump pump lines. They are tying them into the existing header that is there. That water will go into our main line and into the drainage system. North Pompess has already been done. We are scheduled to start North Randolph. I do not have the date yet but will share it once I do. That completes my report.
