Meeting Minutes

Mayor Segrest announced that the Regular Meeting of the Township Committee was being held in accordance with the "Open Public Meetings Act," P.L. 1975, c.231, having been duly noticed to the Burlington County Times and the Courier Post on January 8, 2021.

PRESENTATIONS:

Acting Mayor Kuzowsky announced that there were two presentations on the agenda this evening.

Spotlight Cinnaminson Business Program –

The purpose of the Spotlight Cinnaminson Business program is to recognize a local business that has made special efforts to improve or contribute to the community. The Township plans on recognizing several businesses annually. Examples include beautification efforts such as landscaping, flowers, and other enhancements to structures and/or property, community contributions, job creation, and green and sustainable practices. Nominations of businesses were made by Cinnaminson Township residents. While several nominations were received, the business being recognized tonight is Haines Farm and Garden. This family run business has been operating in Cinnaminson for over 115 years and generously supports countless community events and groups. The nominator cited Haines Farm and Garden as a "quintessential hometown business." The owners of Haines Farm and Garden were unable to join us tonight, but I congratulate them on being the first business recognized through this program and thank them for being a shining example for our business community.

Acting Administrator Ruggieri introduced Joseph Barbadoro from Remington & Vernick to speak about the East Riverton Park project.

East Riverton Park -

ACTING ADMINISTRATOR RUGGIERI: Good evening. This Township Committee has made park improvements a focus of their administration's goals for the community. Recently, playground improvements were completed at Extension Park, lighting upgrades were completed at Memorial Park and plans for additional lighting upgrades at Wood Park are underway. In addition, funding has been included in the Capital Improvement Program and two grant applications have been submitted for additional funding to assist with upgrades to East Riverton Park. Tonight, we are able to share with everyone renderings of the proposed improvements as designed by Township Engineer Remington and Vernick. The Township's Parks and Recreation

Advisory Committee identified this project over a year ago based upon community feedback. In addition, several residents provided direct input to that committee as they developed a concept. The proposed improvements include a natural grass multi-purpose athletic field, refurbished basketball courts, an enhanced passive recreation area with picnic tables and grills, additional lighting and an expanded parking area. Remington and Vernick's Joe Barbadoro is here to highlight some of the features of the proposal.

COMMITTEE LIAISON REPORTS:

Acting Committee Member Brooke Howe: Administration and Health & Senior Services

The inaugural meeting of our Route 130 Advisory subcommittee was held on Tuesday. The committee includes members from our Planning Board, Economic Development Committee and residents. The purpose is to review the county Route 130 Corridor plan and provide input for items that are pertinent to Cinnaminson. This evening there is a resolution on the agenda to move forward with this activity.

For Health and Senior Services - I would like to remind everyone that the Cinnaminson Township website has a section that addresses the ongoing senior activities in our Community Center, as well as contact information for county senior resources, including the Burlington County Office on Aging, Access Link, and others. This can be found on the website at the bottom of the "RESOURCES" tab. It is the section labeled "Wellness and Senior Services"

Last but not least is a reminder to visit and subscribe to the Cinnaminson YouTube channel for videos of meetings and township activities. This can be accessed directly on YouTube, or by clicking on the video embedded in the "NEWS and EVENTS" section of the Cinnaminson website. Also in that section of the website you can find the latest monthly newsletter and a calendar of events

Acting Committee Member Emily Renouf: Finance and Economic Development

Good evening. As we enter the fourth quarter of calendar year 2021, many of the efforts of the Economic Development Committee are reaching new milestones. Please allow me to highlight a few of these accomplishments:

Known as the Westrum project which consists of a 142 bed independent living, assisted living and memory care facility, Westrum and the operator has received almost all of the necessary governmental approvals and we look to finalize the sale of this land which totals approximately 3.5 acres in the next 30 days. Based on the current schedule construction should begin in January.

Next door, LIDL has just about completed construction of their new grocery store. Some site work remains and they will very soon begin screening, interviewing and hiring employees. Cinnaminson residents will be given preference in this process.

A couple of smaller projects: the former Bayard's Chocolates is being developed in to a holistic center, a new tenant is planned for the Starbucks center, Children of America Learning Facility is up and operational and the Burlington Design Center will be occupying the end cap at the Chestnut Hill Drive plaza. Tim Horton's Coffee and Popeye's which will occupy the old Tri-Boro Car dealership site at 130 and Taylor's Lane will begin their site preparation in the next few weeks. McDonald's s will be constructing a new drive thru lane increasing the number of order points from, 1 to 2. Construction has begun for a Jiffy Lube car care center at the corner of US Route 130 and Willow Drive.

In cooperation with State and County official, and the County has been a great partner with our economic development efforts, we continue our intense planning efforts for the Route 130 corridor. Also, we continue to examine opportunities in the industrial zone including anticipating a new building at Mainline Boulevard and Wallace Boulevard.

Cinnaminson Township Police Department Participates in National Takeback Day. Acting Deputy Mayor McDermott: Parks & Recreation and Veterans Affairs

For Parks and Recreation-I am happy to report that the township had a successful Fall Festival this past weekend. The weather threw a bit of a monkey wrench into our plans, and we had to utilize our rain date, but the event went off without a hitch. I want to thank our Township Staff, our Cinnaminson Police Department, the Parks and Recreation Committee, our volunteer first responders as well as our volunteers for making this such a fantastic event. We have some additional activities and events for the residents in the coming months. The first event of note is a Drive-In-Movie night on October 30th at 6:15 at Cinnaminson High School. The Township Holiday Lighting Celebration will take place the first weekend of December; we are finalizing details now. Breakfast with Santa is scheduled for Sunday December 12th at The Merion. Finally, we are in the process of working with staff on scheduling the annual Senior Dinner, which is slated for mid-December.

For Veteran's Affairs-Veteran's Day is Thursday November 11th. Veterans Day is a celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good. Throughout our history, military service members have put on their uniforms to protect our nation and safeguard the values and liberties that this nation was built on. This commitment doesn't stop once the uniform comes off and their time in active duty

has ended. This Veteran's Day, we honor the men and women who have worn their uniform and who continue to serve our country.

Acting Mayor Kuzowsky: Public Works

The Wayne Avenue Bridge construction has officially started. Crews are working daily to complete the new bridge; current estimated date of completion is the New Year.

A reminder that this is the last month for <u>curbside brush</u> clean up. Please see the Township's website for collection dates if needed. Both Sections 1 and 2 have been completed and crews are working through section 3.

November will be the first month for curbside leaf collection. Please see the Township's website for collection dates if needed.

Public Works is currently paving Township Roads Sequoia Drive and Glacier Drive this week.

Starting in November, PSE&G will begin road restoration in the 'Rolling Greens' section of town that has been torn up from the newly installed gas mains.

Lastly, the next bulk collection in town will be on November 3rd and 4th. This concludes my report.

Mayor Segrest asked for a motion to open public comment on Ordinance 2021-12. MOTION TO OPEN PUBLIC COMMENT MADE BY MR. CONDA, seconded by Mayor Segrest. Voice vote. All aye.

Ben Young, 116 Woodview Lane commented that he believes the ordinance is not currently being enforced as it is. Mr. Platt explained that this ordinance is directed at automotive repair shops.

Seeing no one else come forward Acting Mayor Kuzowsky asked for a motion to close the public comment on Ordinance 2021 – 12. MOTION TO CLOSE PUBLIC COMMENT MADE BY ACTING COMMITTEE MEMBER MCDERMOTT, seconded by Acting Committee Member Camnitz. Voice vote please. All aye.

Mayor Segrest asked for a motion to close public comment on Ordinance 2021-12. MOTION TO CLOSE PUBLIC COMMENT MADE BY MR. HORNER, seconded by Mrs. Kravil. Voice vote. All aye.

Acting Mayor Kuzowsky asked for a motion to approve Ordinance 2021 – 12. MOTION TO APPROVE ORDINANCE 2021-12 MADE BY ACTING COMMITTEE MEMBER RENOUF, seconded by Acting Committee Member Camnitz. Roll call vote. All aye.

Mayor Segrest asked for a motion to approve Ordinance 2021-12. MOTION TO APPROVE ORDINANCE 2021-12 MADE BY MR. MCGILL, seconded by Mr. Conda. Roll call vote. All aye. Ordinance 2021-12 was approved.

CONSENT AGENDA:

Acting Mayor Kuzowsky asked Acting Administrator Ruggieri to provide some insight on tonight's consent agenda.

- 1) Resolution 2021–136 Authorizing Extension of 2019 Municipal Aid Grant for Reconstruction of Union Landing Road, Phase II. This phase of Union Landing Road improvements includes the reconstruction of this roadway between Wallace Boulevard and Hunter Street. This work will be completed in conjunction with Phase III, which includes reconstruction of the roadway from Garry Road to Wallace Boulevard. Survey work is being completed so the project can be bid in the near future.
- 2) Resolution 2021–137 Authorizing Participation in Burlington County Cooperative Purchasing Agreement. Chief Financial Officer Julia Edmondson recommends that the Township participates in this three-year cooperative agreement to obtain competitive pricing and timely delivery of certain goods and services including, but not limited to, asphalt, stone, fuel, cold patch mix, line striping, concrete, office supplies, rock salt and track control equipment.
- 3) Resolution 2021–138 Designation of Curfew for Mischief Night and Halloween. This action is consistent with the annual 9:00pm curfew established by the Township and is supported by Police Chief Richard Calabrese.
- 4) Resolution 2021–139 Authorizing Adoption of Amended Personnel Handbook. Per Division of Local Government Services Best Practices, the Township is required to update its personnel handbook every five years. In addition, over the course of the past few years, the Township has adopted several policies which need to be incorporated into the handbook. Thus, both Labor Counsel Carmen Saginario and CFO Julia Edmondson recommend that the governing body adopt the amended employee handbook.
- 5) Resolution 2021–140 Review and Approval of Fire Commissioner Compensation. Per Division of Local Government Services Best Practices, the Township is required to review and approve the compensation of Fire District Commissioners. The \$3,000.00 annual compensation has not changed in many years. CFO Julia Edmondson recommends that the governing body authorize this resolution.
- 6) Resolution 202–141 Authorizing Cancellation of Taxes for a Totally Disabled Veteran (Block 3101, Lot 14). Tax Assessor Dennis DeKlerk and Tax Collector Sandy Root have determined that the owner of this property is eligible for this tax benefit.
- 7) Resolution 2021–142 Authorizing Cancellation of Taxes for a Totally Disabled Veteran (Block 1916, Lot 4). Tax Assessor Dennis DeKlerk and Tax Collector Sandy Root have determined that the owner of this property is eligible for this tax benefit.
- 8) Resolution 2021–143 Authorizing Cancellation of Taxes for Demolished Residential Structure (Block 1925, Lot 15). Tax Assessor Dennis DeKlerk has confirmed that

demolition of this structure is complete and therefore should be removed from the 2021 tax bill.

- 9) Resolution 2021–144 Authorizing Refund of Overpaid Taxes for Totally Disabled Veteran (Block 307.7, Lot 4). Tax Collector Sandy Root has determined that the owner of this property is eligible for this refund due to recently approved totally disabled veteran tax status.
- 10) Resolution 2021–145 Approval of Change Orders and Payment to Diamond Construction for ADA Ramps Improvements. Township Engineer Pennoni has deemed this project substantially complete and recommends change orders in the amount of \$16,717.85 and final payment in the amount of \$94,875.17.
- 11) Resolution 2021–146 Authorize Statement of Intent to Pursue Plan Endorsement and Submit Municipal Self-Assessment Report to the New Jersey State Office of Planning Advocacy. The Township is currently working with the Burlington County Economic Development and Regional Planning Department on updating the New Jersey State Planning Commission's Route 130/Delaware River Corridor Strategic Plan. Recently, as required for plan endorsement, the governing body authorized a local subcommittee to work through the process and make recommendations to the governing body. This subcommittee has been working with Township Planner Ed Fox and Burlington Bridge Commission Regional Planning Manager Tom Stanuikynas on updating the municipal self-assessment report to forward to the New Jersey State Office of Planning Advocacy. The subcommittee and associated professionals recommend that the governing body authorize the self- assessment report.
- 12) Resolution 2021–147 Approving and Authorizing the Consummation of Sale of Real Property to Commerce Pursuit Capital, LP Redevelopment Plan and Authorizing the Proper Municipal Officials to Execute Documents in Accordance with the Plan. The closing on the purchase and sale of the property associated with the Planning Board approved project for a Senior Living community will soon be finalized and Township Solicitor Stuart Platt recommends that this resolution is authorized by the governing body so the Mayor and/or his designee may execute any associated documents on behalf of the Township.
- 13) <u>Resolution2021–148</u> Authorizing <u>Lidl US Operations to Erect Temporary Signage</u>. Lidl representatives have requested permission from the Township to erect temporary signage on their project site to assist them with their employee recruitment efforts as they move toward opening their new store. In an effort to support this new business, the recommendation is to authorize the proposed action.

END OF CONSENT AGENDA

Mr. Platt further clarified that Resolution 2021-147 is regarding part of the Route 130 Redevelopment, the sale of the property to Westrum, which will be building an assisted living facility on that site. This authorizes the mayor and others to consummate the closing of the title. We expect the sale to go through in the next 30 to 60 days.

Resolution 2021-148 is for the Lidl building. Lidl is looking to start the hiring of staff and have asked for permission of Committee as the Redevelopment authority to post signage.
