Mr. Schubiger advised that we have not. Ms. Sheppard also asked about signage being put back up, crosswalks being painted, electronic speed signs and status of project at the East Riverton Park. Mr. Schubiger updated Ms. Sheppard on the status of these projects. Mr. Segrest added that the crosswalks are set to be repainted within the next six weeks. Mr. Schubiger gave further detail on the next phase of the progress.
