A RESOLUTION AUTHORIZING AN AGREEMENT WITH THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF BURLINGTON TO ESTABLISH A COOPERATIVE RELATIONSHIP FOR THE CONDUCT OF CERTAIN COMMUNITY DEVELOPMENT ACTIVITIES

WHEREAS, Title II of the National Affordable Housing Act of 1992, commonly known as the Home Investment Partnerships ('HOME") Program, may make federal funds available to the County to expand the supply of decent and affordable housing; and

WHEREAS, the Housing and Community Development Act of 1974, as amended and supplemented (24 U.S.C. 93-383 et seq.) (the "Act"), provides that Community Development Block Grant ("CDBG") funds may be used for the support of activities that provide decent housing and suitable living environments and expanded economic opportunities principally for persons of low- and moderate-income and said funds may be made available to the County for the operation of CDBG Programs on satisfaction of certain criteria; and

WHEREAS, an urban county and constituent municipalities can ask the U.S. Department of Housing and Urban Development ("HUD") to approve the inclusion of municipalities as part of the Urban County for purposes of planning and implementing a joint community development and housing assistance program; and

WHEREAS, New Jersey law authorizes counties and municipalities to enter into agreements with each other and the Township of Cinnaminson (the "Township") wishes to participate with the County of Burlington (the "County") to implement programs for which these funds may be used; and

WHEREAS, the Township of Cinnaminson has been a historical participant in the Burlington County Community Development Block Grant Program and seeks to continue that participation in 2024-2026; and

WHEREAS, the Township and County wish to enter into a joint agreement for those years.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cinnaminson, County of Burlington and State of New Jersey that an agreement between the Township and the Board of County Commissioners of the County of Burlington, attached hereto as Schedule "A", to establish a cooperative relationship for the conduct of certain community development activities is hereby approved.

BE IT FURTHER RESOLVED that the Mayor and Township Clerk of the Township of Cinnaminson are hereby authorized and directed to execute said Agreement and any additional documents that are necessary to effectuate this Resolution.

SUPPORTING THE APPLICATION OF BLOSSOM CANNABIS TO OPERATE A CLASS 1 CULTIVATION, CLASS 2 MANUFACTURING AND CLASS 5 RETAIL FACILITY IN THE CANNABIS ESTABLISHMENT OVERLAY ZONING DISTRICT OF THE TOWNSHIP OF CINNAMINSON

WHEREAS, the Township Committee of the Township of Cinnaminson ("Township") adopted ordinances amending its Zoning Code to permit adult use cannabis businesses within the Township, under the terms and conditions of Chapter 525 of the Code of the Township; and

WHEREAS, Blossom Cannabis has provided sufficient information to the Township to demonstrate site control over the property located at 2203-2205 Wallace Boulevard (Block 803, Lots 8, 26 and 27) as well as a Zoning Verification Letter dated June 1, 2023 from Edward Fox, AICP, PP, Township Planner.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Cinnaminson, in the County of Burlington and State of New Jersey, that:

- 1. The provisions of the Whereas Clauses set forth above are herein incorporated by reference and made a part hereof.
- 2. This Resolution applies to Blossom Cannabis and their proposed uses to be located at 2203-2205 Wallace Boulevard (Block 803, Lots 8, 26 and 27) in the Township of Cinnaminson within the Township's Cannabis Establishment Overlay Zone in the IND Industrial Zoning District.
- 3. The Township of Cinnaminson through the enactment of Ordinance 2021-7, has authorized cannabis business licenses to operate within its Cannabis Establishment Overlay Zone in the IND Industrial Zoning District upon receiving the appropriate and other applicable local approvals.
- 4. The operation of Class 1 Cultivation, Class 2 Manufacturing and Class 5 Retail facilities within the Township requires the license holder comply with any applicable site requirements, local Ordinance requirements, including but not limited to Chapter 525 of the Township Code, all state law and regulations, any terms and conditions of the Class 1 Cultivation, Class 2 Manufacturing and Class 5 Retail licenses, and the issuance of a municipal business license in accordance with the Code of the Township of Cinnaminson.
- 5. The Mayor, Administrator, and/or Professionals or their designees for the Township of Cinnaminson are hereby authorized to communicate with the Cannabis Regulatory Commission as necessary to confirm and/or supplement the contents of this Resolution as may be requested by the Commission.
- 6. The Township takes no other positions apart from the aforementioned regarding the issuance of a license to the applicant.
- 7. This Resolution of Support shall expire within one hundred and eighty (180) days of its adoption unless the applicant or its designee has received local land use approvals or unless such period of time is extended by further resolution of the Mayor and Township Committee."
