RESOLUTION AUTHORIZING AN AMENDED SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF LUMBERTON FOR CONSTRUCTION OFFICIAL SERVICES

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (hereinafter the "Shared Services Act"), authorizes local public entities to enter into a contract with other local public entities for the joint provision of any service which any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the Township of Lumberton ("Lumberton") and the Township of Cinnaminson ("Cinnaminson") are public entities organized under the laws of the State of New Jersey and located in the County of Burlington; and

WHEREAS, on or about adopted on April 5, 2021, authorized by way of Resolution 2021-63, Cinnaminson and Lumberton entered into a Shared Services Agreement pursuant to the Shared Services Act whereby Lumberton would share the services of its Construction Code Official with Cinnaminson; and

WHEREAS, on April 3, 2023, the New Jersey Department of Community Affairs recommended amending the Agreement to a four-year term; and

WHEREAS, Lumberton and Cinnaminson have agreed with the recommendation of the Department of Community Affairs and therefore seek to amend the Shared Services Agreement to reflect the four-year term, commencing from the initial effective date of the Agreement, March 18, 2021; and

WHEREAS, the Agreement shall be amended for the term to commence on March 18, 2021 and terminate on March 18, 2025, unless terminated sooner pursuant to the terms of the Agreement ("Term"); and

WHEREAS, Lumberton and Cinnaminson have agreed to amend the compensation paid by Cinnaminson to Lumberton to reflect the amended Term.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Cinnaminson, County of Burlington and State of New Jersey that the amendment to the Shared Services Agreement between the Township of Cinnaminson and the Township of Lumberton attached hereto as Exhibit "A" is hereby approved.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Cinnaminson, in the County of Burlington and State of New Jersey, that:

- 1. The provisions of the Whereas Clauses set forth above are herein incorporated by reference and made a part hereof.
- 2. This Resolution applies to Elite Business Management and its proposed use to be located at 2300-2302 Wallace Boulevard (Block 804, Lots 7 and 8) in the Township of Cinnaminson within the Township's Cannabis Establishment Overlay Zone in the IND Industrial Zoning District.
- 3. The Township of Cinnaminson through the enactment of Ordinance 2021-7, has authorized cannabis business licenses to operate within its Cannabis Establishment Overlay Zone in the IND Industrial Zoning District upon receiving the appropriate and other applicable local approvals.
- 4. The operation of a Class 1 Cultivation and Class 2 Manufacturing facility within the Township requires the license holder comply with any applicable site requirements, local Ordinance requirements, including but not limited to Chapter 525 of the Township Code, all state law and regulations, any terms and conditions of the Class 1 Cultivation and Class 2 Manufacturing licenses, and the issuance of a municipal business license in accordance with the Code of the Township of Cinnaminson.
- 5. The Mayor, Administrator, and/or Professionals or their designees for the Township of Cinnaminson are hereby authorized to communicate with the Cannabis Regulatory Commission as necessary to confirm and/or supplement the contents of this Resolution as may be requested by the Commission.

6.	The Township takes no other positions apart from the aforementioned regarding the
	issuance of a license to the applicant.

7. This Resolution of Support shall expire within one hundred and eighty (180) days of its adoption unless the applicant or its designee has received local land use approvals, unless the period of time is extended by further resolution of the Mayor and Committee.

WHEREAS, the Palmyra Ambulance Association is in need of a new ambulance in order to best serve local residents, including the residents of the Township; and

WHEREAS, the Township wishes to purchase a Type II TSE Ford Transit Ambulance from First Priority Emergency Vehicles for \$194,268.00; and

WHEREAS, upon purchase of the Type II TSE Ford Transit Ambulance the Township of Cinnaminson plans to transfer same to the Palmyra Ambulance Association; and

WHEREAS, on September 6, 2019, the Cinnaminson Township Fire District #1 and the Palmyra Ambulance Association have entered into an agreement whereas the Palmyra Ambulance Association is to provide emergency services to the residents of Cinnaminson Township; and

WHEREAS, the Township Committee adopted Resolution 2019-153, recognizing and accepting the aforementioned agreement whereby the Palmyra Ambulance Association would provide emergency medical services to residents of the Township; and

WHEREAS, pursuant to N.J.S.A. 40:5-2, the Township is permitted to appropriate funds as it may deem necessary for the purchase of ambulance vehicles for use by duly incorporated first aid and emergency ambulance associations; and

WHEREAS, the Township has determined it to be in the best interest of the residents of the Township to purchase this ambulance for use by the Palmyra Ambulance Association.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Cinnaminson, in the County of Burlington and State of New Jersey, that:

- 1. The purchase of Type II TSE Ford Transit Ambulance from First Priority Emergency Vehicles for the price of \$194,268.00 is hereby authorized; and
