Public Works – Mr. Segrest

Public Works Department personnel are collecting real Christmas trees for the month of January. Residents do not need to call for scheduled collection. Trees that are free of lights, ornaments, stands and not in a bag will be collected. No additional brush will be collected at this time.

Trees located along Union Landing Road have recently been removed in preparation for the construction of a new sidewalk. Replacement trees will be installed at the end of the project. In addition to the tree removal, local utility companies have begun work on relocating the necessary utilities to allow for additional stormwater control infrastructure to be installed.
