**WHEREAS**, the Township awarded the FY 2022 Local Freight Impact Fund Resurfacing of Taylor's Lane Project to Black Rock Enterprises; and

**WHEREAS**, the Township Engineer has confirmed that the project is now substantially complete as set forth in the copy of the Engineer's letter dated April 3, 2025 annexed hereto as Exhibit "A"; and
