CINNAMINSON TOWNSHIP COMMITTEE August 4, 2025

Meeting Minutes

Mayor Kravil asked for a moment of silence to acknowledge the passing of Cinnaminson Township Solicitor Carmen Saginario Jr. and John Hunter, the Patriarch of Hunter's Farm and Market. Both of these men were longtime residents and heavily involved in the Cinnaminson community and activities. Our thoughts and prayers are with the families of both Mr. Saginario and Mr. Hunter.

Mayor Kravil announced that the Work Session Meeting of the Township Committee was being held at 6:30 p.m. in the Municipal Building, 1621 Riverton Road, Cinnaminson, NJ 08077. This meeting is being held in accordance with the "Open Public Meetings Act," P.L. 1975 c.231, having been duly noticed to the Burlington County Times and the Courier Post on January 10, 2025.

Damien Del Duca made a presentation from Del Duca Lewis & Berr Law Firm representing Flagship New Jersey Propco, LLC regarding their proposal to build a Flagship Car Wash at the former Sweetwater Bar and Grill property located at 10 Route 130. Also present were Judy Knop from Flagship New Jersey Propco, LLC, Jose Lazo, Civil Engineer, Kelly Beaudreau-Hwang, Architect, Nathan Mosely, Project Engineer, George Kyrtatas, owner of 10 Route 130, Sweetwater Bar and Grill, Jay Miller, Broker for Property Owner, and John McDonough, Planner.

Ms. Knop provided the background of Flagship New Jersey Propco, LLC, and detailed the proposed car wash. Mr. Lazo presented a concept plan for the car wash and an overview of how the car wash would function. Ms. Beaudreau-Hwang presented renderings of the proposed building for Cinnaminson and gave an overview of the primary architectural features of the building. Mr. Mosely confirmed that he has evaluated the adequacy and safety of the proposed access to the car wash and that the noise impact on adjacent properties is acceptable. Mr. Kyrtatas spoke about changes to the site and how his site and the surrounding sites were affected, including access roads to the sites and how and by whom they are used. He stated that in 2024, they closed the Sweetwater Bar and Grill and began marketing the property. He stated that he feels that the proposed project is the best deal for the town. Mr. Miller stated that he was hired in July 2023 by the Kyrtatas's. He gave a background of businesses that have looked at this site and the challenges with converting the building and layout of the site and parking. Lastly, Mr. McDonough stated that he has reviewed the redevelopment plan and master plan. He believes this project is consistent with the redevelopment plan and ordinance.
